## Deposit Contract

As a sign of good faith of my/our intention to purchase this pet, I/we have paid

I understand that the Deposit will reserve the puppy for me, until I have made  
arrange-ments to pay in full for the animal and/or it is old enough to  
leave the Home of the breeder, usually between 8 and 9 weeks of age, depending  
on the size and development of the individual pup.

**This is a non-refundable Deposit!** I/we understand, that if I do not pick up my pup at the specified time, and/or fail to make agreed upon Installment or Final Payments, Ms. Greene will make the above described animal available to other homes and is entitled to keep the Deposit for Liquidated Damages.

**Exception:** On the odd chance that the chosen puppy or dog fails to pass its Initial or Final Wellness-Check at our or your Vet due to Congenital Defects, Ms. Greene will opt to replace the pup/dog with a similar pup from the same or different litter. In case none are or will become available during the following 6-8 week period, Ms. Greene may choose to refund the deposit and will release the Buyer from any Obligations to Purchase. However - the Purchaser may, if that is desired, choose another pet of comparable value, of the same or different Litter, at any time as long as any are deemed available, or may be allowed first choice of a new litter that is due to be born within the next 3 months following the contract date.

**If, according to our Vets advise the animal is healthy, but still too young or undeveloped to be turned over to a new owner, it must remain with Ms. Greene until our Vet approves of its' move to its' new home.** This is not a reason for Breach of Contract - we are just concerned about the Well-Being of your future Family Member, and so should you! However - if there is a sibling or similar puppy of comparable value ready to go, the Deposit may be transferred towards another puppy. Any effort is being made to find a mutually agreeable solution.
